ORDER

As per paper read (1) above, applications were invited applications for continuation of provisional affiliation for the academic year 2018-19, from colleges for courses affiliated to the University. The Principal, Government Medical College, Ernakulam-MM004 vide paper read (2) above has submitted application for the continuation of provisional affiliation for the year 2018-19.

On verification of the applications it is found that the College has submitted necessary documents and remitted fee for continuation of provisional affiliation for the year 2018-19. Inspection was conducted at Govt Medical College, Ernakulam -MM004 and inspection report was submitted vide paper read (3) above. The Scrutiny Committee meeting vide paper read (4) above, has scrutinized the inspection report and pointed out major deficiencies of faculty and equipment. The College vide paper read (5) above has submitted the compliance report and the Scrutiny Committee vide paper read (6) above, has scrutinized the compliance report and find out that the deficiencies were rectified only partially. The Director of Medical Education and the Additional Chief Secretary, Ministry of Health and Family Welfare (Govt of Kerala) vide paper read (7) and (8) above respectively have submitted undertakings stating that all deficiencies pointed out will be rectified before commencement of the class of academic session 2018-19 MBBS batch. After considering the matter, the Hon'ble Vice Chancellor vide paper read (9) above, has accorded sanction to grant conditional Continuation of Provisional affiliation to Govt Medical College, Ernakulam for conducting the following courses with an annual intake of students mentioned against each during the academic year 2018-19 subject to ratification by the Governing Council and the conditions detailed below.

- 1 Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
- 2 In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- 3 Affiliation granted is strictly provisional and only for the academic year 2018-19. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- 5 Admission to the next academic year shall be made only after obtaining prior permission from the University.
